We have some important milestones coming up in the life of the fraternity, first and foremost is the celebration of the national fraternity's centennial anniversary. Next Spring will mark the 100th anniversary of the founding of the fraternity, followed a year later by the 75th anniversary of the founding of Zeta chapter. The national organization is busy planning for their celebration in St. Louis in February, and I hope to see many of you there. We will also start planning to host a 75th anniversary celebration in Manhattan for Zeta in the next few months.

The Fall semester of 2024 is presenting some new challenges for Zeta chapter. The small recruiting class last year put the active chapter in a budget bind, which required them to defer much of the rent due last year. The alumni chapter had to borrow from the national fraternity for the operating funds to pay all our bills and will begin repaying that loan in January.

The slim recruiting trend continued for Fall 2024 with 5 new members joining Zeta chapter. The national fraternity is working with "Phired Up" to offer additional training for several chapters, including Zeta, to improve our recruiting productivity. They are the company behind the Chapter-Builder software that is used by K-State and other schools for contact

The "best practices" we are learning for fraternities is to have two separate entities from the alumni – one for property ownership and management plus one for operational advising of the active chapter. We look for more guidance from the national fraternity on recommendations specific to our fraternity for implementing such an organizational structure. If you would like to volunteer for service with one of those groups, please let me know.

We are happy to welcome William and Tricia Prann as our house parents for this year. They are both energetic and active individuals, making the place better every day.

The financial position and cash flow for the alumni will require some extraordinary measures in order to make ends meet this vear. We continue to need your contributions both financially and spiritually to keep Zeta chapter successful. Dues and donations are needed, and we are also looking for alumni to volunteer in chapter advisory roles.

The Manhattan Alumni Chapter continues to award meaningful scholarships to our students and is well-positioned to continue those awards. The first floor conference room is a center of study for the men at the house, using some of the same technology devices as used in the classrooms. Please let the young men in your lives know what Beta Sigma Psi has to offer in support of their scholastic achievement.

Work Weekend In Manhattan

members gathered in Manhattan to make repairs at the chapter house. The main project they addressed was rebuilding the dumpster fencing and adding new gates to the front of the enclosure. (See photo below

Other projects they completed included the annual removal of weeds and brush that always grows along the west edge of the parking lot during the summer months, and some smaller tasks, like general grass weed-eating and planting bed weeding around the outside of the building and yard, plus disposal of items from within the chapter house.

Chapter Sewer Draining Issues Resolved Bv: Brad Brunkow

There have been several sewer draining issues during the past few years, in the kitchen, the house parents' apartment, and the first-floor rest room. After some camera scanning, the issue found was some very hard deposit build-up in the sewer lines which a standard roto rooter could not remove. The solution was to remove the deposits back to the original inside pipe diameters, all the way to the street. This summer all lines on the first floor were completed, except for the laundry and mechanical rooms. Some clean outs had to be added in the front yard to complete the work. The total cost was \$12,500. The good news was the lines, which are cast iron, were found to be in good condition. We noticed that five feet of line in the kitchen had been replaced with PVC from a past repair. Hopefully now, we will have many more years of problem-free service before something like this needs to be done again.

We are losing our membership and need your help to find them **By: Gary Raffetv**

Over the past twenty years, we have slowly lost a small percentage of our older alums as they age, move around the country, and forget or choose not to notify us of their whereabouts. This is not a new problem; it has been with us for years. But today we face an entirely new kind of problem with our more recent graduates.

The problem of losing touch with the older members of our alumni has remained the same over the years, with the loss evenly distributed among the classes and the percentages remaining low. That has changed drastically over the past ten to fifteen years.

During the eleven years from 2010 to 2020, we graduated a total of one hundred and forty-eight men (148). Of that total, ninety-two (92), which is 60%, are now lost. One died, two chose to disassociate themselves from us, and the remaining ninety-eight (98) graduated, moved away and never looked back, either forgetting or choosing not to provide us with any contact information.

Not too many years ago, there would have been copies of the documents they all signed when they first joined us, filed away in the filing cabinet in the President's room. On those documents were the names of their parents, the home address, phone numbers and in most cases, the email addresses of their parents. Unfortunately, times change and so do the practices of those that manage our chapter.

Now, in the digital world of zeros and ones, the digital way has destroyed the age-old practice of keeping hard paper copies of all important records. Today's generation have been taught to go paperless, so they dispose of all paper records and have no use for the filing cabinet. All chapters are supposed to send digital copies of these records to national, but few do and then it is only a matter of time until the digital copies become a storage problem and are deleted. When this happens, we no longer have records needed to locate our graduates.

When students are in school, they have access to free internet with KSU and thus free emails. When they leave school, this free internet ends and they must get a new email address. This is another link that is broken and if they do not re-establish it with us, we lose another way of reaching them.

I have been the keeper of the MAC database for the last 25 years or so and it has never been harder to keep the file up to date than right now. I think you can attribute most of the difficulty to culture change. Drastic technology change and its effect on our daily lives, social attitude changes and their effect on the way people live and interact with one another, loss of respect for tradition and the lack of the need to join or belong to anything as opposed to a few decades ago.

I have no idea what is going to happen to Zeta chapter if this trend continues unabated, but it could lead to our demise. They say the pendulum always swings back and forth and so maybe societal changes will change in a positive way, eliminating the current trend. In any case, until something like that happens, we need to try to find a way to counter our current problem. If anyone out there has a suggestion, feel free to contact any of the current board members. Their contact information is on the back page of the newsletter.

Fortunately, our chapter house is paid for, but the costs are high to maintain a large facility like our chapter house. Taxes and insurance continue to escalate every year and the costs to make repairs increase as well. If we had full occupancy every year, it is quite possible that the financial needs would be met on an annual basis. But then we have not had full occupancy for years and of course there are those big-ticket items that must be dealt when they come along.

Thanks to the Capital Campaign of 2014 to 2019, we completed most of the major items needed for the near future, like a new roof, new windows, major upgrades in the kitchen and housemothers quarters. With all those upgrades behind us, we should not have any major repairs in the near future, with the exception of the air conditioning condensers.

Currently we are facing the eventual need to replace all of our air conditioning condenser units that are way past their normal life expectancy. Thanks to our annual service contract, we have extended the life of our units by almost ten years, but we are on borrowed time now. Ten years ago, it was estimated that it would cost over \$100,000 to replace all of our units, so we know that by now they will be substantially more costly.

We have come a long way in our almost 75 years of existence. We have overcome problems before and hopefully we will overcome those we are facing now, but our current situation is not going to be an easy one to overcome. With the decline in church membership, our recruiting becomes more challenging, and with the continued desire of our members to move out after their sophomore year, filling and keeping a fully occupied chapter house will be a nearly impossible task to achieve.

In closing, our current situation looks hopeless, but God always helps those who seek his help. I am suggesting that now is a suitable time for us to seek guidance from above, because we mere mortals may not be up for this task without his help. We have a great organization, and we need to do all we can to make sure that we see our 75th anniversary and many more after. We have graduated hundreds of good Christian members; we must do all we can to keep it going for future generations.

Is Our Future At Risk

ldb been my privilege for the past 17 years, from 2007 to 2023, to serve as the collector of all annual alumni donations, (dues and gifts) for the Manhattan Alumni Chapter. I have kept accurate files annually and because of that, I was able to create the annual donation list on pages 8, 9 and 10. It took many long hours to compile, but I thought it was important to find out who has been donating, how much has been donated, (by age groups and classes, not individuals), and take a look at the unfolding trend for Zeta donations from our alumni. The picture that was created, quite frankly, does not

Time keeps moving onward, and as a result, we have lost many of our best donors from the fifties and sixties. A high percentage of alums that donated on a regular basis and often with substantial gifts are gone and I do not think their level of giving will be matched by our more recent graduates. We still have good donors, who are also very generous, but in far fewer numbers than in past years.

What is of great concern to me is the lack of interest from our more recent graduates, from the 1990's on. The vast majority of the 1990 - 99 classes and the 2000 - '09 classes - have not been donating, and after the 2012 class, donations do not exist. If you look at the chart, it is easy to see the drop off in donations and they are drastic.

We are facing some major cultural changes that were not present in our chapter's early years, and they are having a major impact on our chapter. It was explained to me by a younger board member at a board meeting several years ago, that today's students, and those from his era a decade earlier, do not share the same passion for the fraternity that the older generations did. He said that they view their stay in the House as just another phase or chapter in their life, something to be enjoyed at the time, but then it is over and time to move on with no looking back. In other words, as the saying goes - "been there - done that - time to move on."

Looking at the donation chart on pages twelve (12) and thirteen (13), the numbers substantiate his statement. If you look at the lost numbers, you will see that in the twenty years from 1951 to 1970, there are five (5) lost members, then in the twenty years from 1970 to 1989, there are eight (8) lost members. During the two decades from 1990 to 2009, there are six (6) lost members, but then in just ten (11) years, from 2010 to 2020, there are ninety-nine (99) lost members. This clearly indicates a major change of some kind.

If you look at the small charts shown near the bottom of page 12, that list the donations by decade, you will see the steady decline in donations from the decade of the fifties through the decade of 2010 to 2019. The fifties decade gave over \$55,000 in dues and gifts to the chapter. The decades of the sixties and seventies were about the same, but then the decline starts with the decade of the eighties.

The decade of the eighties gave just under \$40,000. The decade of the nineties dropped down to around \$11,500, followed by another substantial drop during the decade of 2000 to 2009 of less than \$3,300. Then there is the complete drop off of the last decade, 2010 to 2019 which has a combined donation total of \$700. It has been suggested this is because we do not have a digital payment plan in place. That could be part of it, but a very minor part of it. This is an attitude change in my opinion. That being said, I do think we need to provide a digital payment process as most people now are using there phones and computers to pay for just about everything.
